ELIGIBLE BREEDS AND REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis and Whippets may be entered in the regular stakes. All entries shall be individually registered with the American Kennel Club, The National Greyhound Association, the United Kennel Club, the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA board approved registry, or possess a Critique Registration Number (CRN) from the Society for the Perpetuation of the Desert-Bred Saluki (SPDBS). Limited/Provisional breed entries must be individually registered with the appropriate registry

GENERAL INFORMATION

- All entries must be one year of age or older on the day of the trial
- Stakes will be split if 20 or more entries are present in any one stake at the time of the draw.
- The tentative SPLITTING of FLIGHTS (as applicable) will be performed on the trial site at the FTS desk upon the close of entries.
- Bitches in season, hounds with breed disqualifications, and lame hounds will be excused
- All hounds will run twice, in trios if possible, or braces, unless excused, dismissed or disqualified
- Monorchid, cryptorchid, spayed, or neutered hounds may be entered.
- Hounds not present at the time of Roll Call will be scratched and entry fees will not be refunded
- Electrical-powered, continuous loop lure machine will be used with back-up equipment available
- The lure will consist of light and/or light colored plastic and/or fur.
- Muzzles are not required; it is the responsibility of the owners to determine if their hound should be muzzled
- Certifications will be offered after the conclusion of the event and as equipment and daylight allow. Certification runs are \$8 each. For other certification offerings, see LSBC's Friday premium list or our Sunday premium list for this 3-day event.
